Dear Speaker Ryan, Leader Pelosi, Leader McConnell, and Leader Schumer:

A month from today, the Deferred Action for Childhood Arrivals (DACA) policy will end. When it does, hundreds of thousands of bright and talented young people are at risk of being deported from the only country they have called home.

When the Trump administration announced Sept. 5 it was rescinding DACA, the president granted a six month delay in order for Congress to pass legislation to provide a permanent solution. Last week, President Trump proposed that Congress approve a fix that would extend legal status to 1.8 million Dreamers, including all of those who have been enrolled in DACA, and provide them with a pathway to citizenship.

As Congress faces a deadline this week to pass funding legislation and keep the government open, we urge lawmakers not to lose sight of the need to adopt legislation providing permanent legal status for DACA registrants and Dreamers, as the president and a number of lawmakers on both sides of the aisle have proposed.

For over a decade, we have advocated for a long-term legislative fix for Dreamers. Following the rescission of DACA last year, more than 800 college and university presidents urged lawmakers to take action to protect DACA registrants, as did nearly 80 higher education associations.

These outstanding individuals are Americans in every way but immigration status, and are making countless positive contributions to our nation. They are our students and colleagues; they are teachers, health-care professionals, and police officers; and they are serving in our military. They have been living in fear and uncertainty for far too long. We would not tolerate any other segment of our population, let alone a group of such high-achieving individuals as the DACA beneficiaries, being left in limbo this way.

There is widespread bipartisan support for protecting Dreamers and we urge you to find a bipartisan solution. It is unacceptable for these young people to be held hostage to other issues.

The time to act is now.
